163.7 Neighbourhood Plan:

Jane Smith and Laura Brennan advised that the neighbourhood plan is now in the consultation phase. This is a 6 week period and correspondence had been issued to all parishioners, local businesses and affected parties. Once the consultation period has expired the draft plan will be submitted to ERYC for an independent examination.

164.8 Planning:

One application has been received:

Ref 18/00337/PLF Change of use from paddock to accommodate 6 holiday lodges and lake and creation of new vehicular access - land west of Fouracres, Main Street, Allerthorpe-The PC has objected to this application.

164.9 Traffic issues

A report had been prepared for ERYC highlighting 8 potential traffic calming measures. ERYC rejected all 8 on the basis that either funds were not available to support the measure or there were statutes already in place.

However, a traffic survey was completed which showed that traffic was travelling through the village at increased speeds. A second survey commenced Monday 9th April and will continue for 7-8 days this is looking at high sided vehicles coming through the village and is part of a survey being carried out by Melbourne Parish Council. The results of the second survey will be shared with Chris Mills and he and the group will review these and report back to Parish Council once more. Chris Mills did advise that we may have a police presence in the village as a result of the increased speeds shown in the first traffic survey.

b. The PC has received a survey from ERYC on communication and how ERYC communicates with parish councils. PW to complete and return.
